**Deposits** ***Residential***

Deposits are based on credit inquiry through On-Line Utility Services. Customers with green rating have no deposit. A yellow rating: Elect-\$100, Gas-\$100, Water-\$50. A red rating: Elect-\$150, Gas-\$150, Water-\$75. All customers must pay a \$25 service fee for each service at the time of application. Deposits refunded after 2 years if customer meets HUB criteria. Note: Renters applying for service must have rent receipt in same name as for the utility service.

***High-Risk***

**First-time** disconnection for non-payment, \$25 reconnection fee. The Third time in a 12-month period, a high-risk deposit must be paid, by doubling the maximum deposits on the account plus a \$25 reconnection fee.
